

PRIVACY POLICY (Last Updated March 20/2023)

Protecting your private information is our priority. This Statement of Privacy applies to “Howly” and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to “Howly” include apps and website and “Howly”. The “Howly” platform is a rental marketplace Platform. By using the “Howly” platform, you consent to the data practices described in this statement.

1. Collection of your Personal Information

In order to better provide you with products and services offered on our platform, “Howly” may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Photos of users government issued ID's

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through “Howly”'s public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Platform. These may include: (a) registering for an account on our Platform; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Platform. To wit, we will use your information for, but

not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

2. Use of your Personal Information

“Howly” collects and uses your personal information to operate its platform(s) and deliver the services you have requested.

“Howly” may also use your personally identifiable information to inform you of other products or services available from “Howly” and its affiliates.

3. Sharing Information with Third Parties

“Howly” does not sell, rent or lease its customer lists to third parties. “Howly” may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to “Howly”, and they are required to maintain the confidentiality of your information. “Howly” may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on “Howly” or the Platform; (b) protect and defend the rights or property of “Howly”; and/or (c) act under exigent circumstances to protect the personal safety of users of “Howly”, or the public.

4. Tracking User Behavior

“Howly” may keep track of the platforms and pages our users visit within “Howly”, in order to determine what “Howly” services are the most popular. This data is used to deliver customized content and advertising within “Howly” to customers whose behavior indicates that they are interested in a particular subject area.

5. Automatically Collected Information

Information about your computer hardware and software may be automatically collected by “Howly”. This information can include: your IP address, browser type, domain names, access times and referring platform addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the “Howly” platform.

6. Use of Cookies

The “Howly” platform may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize “Howly” pages, or register with “Howly” Platform or services, a cookie helps “Howly” to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same “Howly” platform, the information you previously provided can be retrieved, so you can easily use the “Howly” features that you customized.

You have the ability to accept or decline cookies. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. If you choose to decline cookies, you may not be able to fully experience the interactive features of the “Howly” services or platforms you visit.

This platform contains links to other Platforms. Please be aware that we are not responsible for the content or privacy practices of such other Platforms. We encourage our users to be aware when they leave our Platform and to read the privacy statements of any other Platform that collects personally identifiable information.

8. Children Under legal age

Howly does not knowingly collect personal identifiable information from children under the age of 18 without verifiable parental consent. If it is determined that such information has been inadvertently collected on anyone the age of 18, we shall immediately take the necessary steps to ensure that such information is deleted from our system's database. Anyone under the age of 18, must seek and obtain parent or guardian permission to use this website.

9. E-mail Communications

From time to time, "Howly" may contact you via email for the purpose of providing announcements, promotional offers, alerts, confirmations, surveys, and/or other general communication. In order to improve our Services, we may receive a notification when you open an email from "Howly" or click on a link therein.

If you would like to stop receiving marketing or promotional communications via email from "Howly", you may opt out of such communications by clicking unsubscribe on the marketing notifications.

10. External Data Storage Platforms

We may store your data on servers provided by third party hosting vendors with whom we have contracted.

11. Changes to this Statement

"Howly" reserves the right to change this Privacy Policy from time to time. We will notify you about significant changes in the way we treat personal information by sending a notice to the primary email address specified in your account, by placing a prominent notice on our Platform, and/or by updating any privacy information on this page. Your continued use of the Platform and/or Services available through this Platform after such modifications will constitute your: (a) acknowledgment of the modified Privacy Policy; and (b) agreement to abide and be bound by that Policy.
